Using the logo



When the logo appears on a white background, this is our preferred representation.




If the logo must be monochrome, it should be displayed like this.






The outline version of the logo, which incorporates a white keyline around the main lozenge, should be used on dark backgrounds.

Logo variations



The standard logo is best used on white or light coloured backgrounds.



A version of the logo is available with a white outline around the lozenge for occasions when it needs to appear on dark blue or black background. The logo should not be placed in a white box when used on a dark background.

Life Smart Waste colour palette

The Life Smart Waste colours are blue and green and should appear wherever possible on a white background. The colours can be achieved by using Pantone colour references or by four-colour process.

Logo elements

Please ensure that the logo elements are not adulterated in any way.





The logo should never be taken apart in any way.





The colours of the logo should never be swopped around.



The logo should not be placed in a white box when used on a dark background.

The standard orientation of the logo provided should not be changed. The only exception would be on the spine of a publication.

Logo aspect ratio

Please ensure that the ratio of the logo is preserved and not distorted in any way. When resizing the logo, care should be taken to lock the aspect ratio (normally by holding down the shift key) so that it is neither condensed nor expanded.
