CONSULTATION ON A PROPOSAL TO AMEND CHARGES FOR THE SPREADING OF ORGANIC WASTE ON LAND

The purpose of this consultation

This consultation seeks your views on proposals to reduce charges for the registration of farms for the spreading of organic waste.

Background

The Waste Management Licensing (Scotland) Regulations 1994, exempt some waste activities from the requirement to have a waste management licence and instead they attract only a SEPA registration fee. These exemptions include the spreading of organic waste on land, including land used for agriculture. Currently the maximum area on each exemption is 50 hectares. As a result, land managers with greater than 50 hectares must make several separate registrations.

Spreading activities must be registered with SEPA and are subject to an application and annual renewal fees. There are currently about 360 such registered activities. Approximately 90 farms have made multiple applications.

The Minister for the Environment Roseanna Cunningham MSP spoke at the Royal Highland Show in June 2009 about the key achievements of Scotland's Environmental and Rural Services (SEARS) partnership in the last year. The Minister highlighted the opportunity to reduce bureaucracy by registering a whole farm in a single registration ("one farm, one form") as a simpler and quicker process which would result in a time saving to customers.

We therefore propose to rationalise and simplify the regulatory approach for these waste exemptions by removing the 50 hectare restriction and allowing all organic spreading activities, taking place on the one farm, to be registered as one. The registration of associated 50 hectare treatment areas on the one farm will take proportionately less time for SEPA to process and we propose a corresponding reduction in fees.

Fees and Charges

Currently the application and renewal fees for registration are £569 and £431 respectively. A farm applying to register 5 treatment areas of up to 50 hectares would currently pay £2,845 in application fees and an annual renewal fee of £2,155.

Proposed amendments

The application and renewal fee for the first registered treatment area will remain the same however we propose to reduce the application fee for each associated 50 hectare treatment site on the same farm to £210 and the renewal fee for each associated site to £180.

As a result, a farm applying to register for example 5 registered treatment areas, which isn't untypical, would pay about 50% lower application fees and 47% lower annual renewal fees.

The average times for each element of the registration and renewal processes and how we calculate the above proposed charges are detailed ANNEXES 1 and 2

Financial Impact of the proposals

This proposal will reduce the number of registrations by almost 50% and reduce customer annual renewal charges by about £29,000.

Charges approval process

Any significant changes to a charging scheme are subject to approval by the Scottish Government and Scottish Ministers. Before submitting proposals to the Scottish Ministers we must consult with interested parties.

The consultation period will be 12 weeks from the date of issue and subject to Ministerial approval; we are aiming to implement the revised charges in June 2010.

The Scottish Government and the Scottish Ministers will consider the comments received on the consultation, while having regard to our requirement to set charges to recover relevant costs and expenses. They will place copies of the consultation responses in their library and SEPA publishes a summary of comments received on the SEPA website.

How to respond

We would like your views on these proposed amendments. We are particularly interested in the reasons behind your views and, where possible, any evidence you have that supports them.

The consultation period closes on 21 May 2010.

^{*} Only certain registrations will require science input but this is likely to require more than one hour of time. As the input generally relates to a specific issue, e.g. the pH or composition of the waste or the nutritional benefit of the waste, this is not likely to increase as the land area increases. We estimate that the average of the time spent by science, spread over all applications, is one hour.

Recommended Charging Option

Rather than applying variable increases for each added treatment area, as in the table above, it is proposed instead that a standard increase of £210 be applied for each additional 50 hectares (or part 50Ha), which will be simpler (as below).
