National capacity report for Scotland - 2007

1. Introduction

This paper presents the numbers and capacities of all waste management sites licensed or permitted by SEPA that were operational (actively receiving waste) in calendar year 2007. This paper is intended as a snapshot of waste tonnages accepted at waste facilities and available waste management annual capacity in 2007.

2. Types of waste management sites

This paper considers the numbers and capacities of the following site types:

- Landfill (open)
- Landfill (restoration)
- Energy from Waste (EfW) plant / Incinerator
- Civic amenity site¹
- Metal recycler (includes End of Life Vehicle and Authorised Treatment Facilities)
- Transfer station
- Pet cemetery/crematorium
- · Composting site
- Anaerobic digestion plant
- Other treatment plant
- Multiple activity site

In some cases, sites are licensed or permitted to carry out two or more waste management activities under the licence or permit and these have been designated as multiple activity sites for the purpose of this report. Further details of these are in the spreadsheet accompanying this report. It should be noted that in the case of these multiple activity sites, it is not possible to allocate capacity or waste tonnage to the separate activities carried out.

3. Numbers of operational waste management sites in Scotland 2007

There were 805 waste management sites in Scotland that received waste in 2007. The number of sites is shown by site type in Table 1.

4. Capacity of operational waste management sites in Scotland 2007

The licensed/permitted annual capacities of the operational waste management sites in Scotland in 2007 are shown in Table 3. In order for capacity figures to be meaningful, a comparison must be made with the quantities of waste accepted per year. This is also shown in Table 3.

^{**} The Landfill Capacity Report for Scotland 2007 presents a snapshot of the total available remaining capacity for all landfill sites classified as hazardous, non-hazadous or inert as at 31 December 2007.

Sites accept waste both from within the local authority boundaries and from all over Scotland and beyond, so waste managed within any given Waste Strategy Area does not necessarily correspond to the waste produced within that area.

5. Capacity of non-operational waste management sites in Scotland 2007

The licensed/permitted annual capacities of sites that are permitted, but not yet receiving waste ('non-operational') in 2007 are shown in Table 5. These are sites which have been granted a licence or permit but are not as yet operating for a variety of reasons (e.g. still under construction, or awaiting commissioning).

6. Data sources and limitations

The data in this report are extracted from SEPA's public register of licensed/permitted sites and from actual returns as supplied by operators of these sites. There have been no estimates applied to the data.

Data on waste inputs to sites holding a waste management licence or relevant pollution prevention and control permit were obtained from licensed/permitted site return forms submitted to SEPA on a quarterly basis. Although checks are made, SEPA cannot be held responsible for any errors contained within the data, nor for commercial decisions taken by operators.

The annual capacity of a site is the quantity of waste that a site is actually licensed or permitted to handle each year. For the majority of sites this information has been obtained directly from the licence/permit. However, in a small number of cases this information is not available.

Facilities that handle waste, but are not specifically licensed or permitted as a waste management facility (eg a paper mill) are not included in the report.

No data is presented here for sites which have planning permission but have not yet applied for, or been issued with, a permit by SEPA.
