

The Register of Approved Bodies lists all organisations authorised by SEPA to receive and distribute SLCF funds to enrolled projects that meet funding criteria. Projects can apply to any of the currently Approved Bodies regardless of location. Projects can apply to any number of Approved Bodies but can only accept funding for a project or particular phase of a project from one Approved Body. Different Approved Bodies can fund separate phases of the same project. Approved Bodies must not select projects for funding on the grounds of geography (other than due to the vicinity rule) or SLCF object (i.e. type of project). Bodies that have had their approval revoked cannot accept SLCF contributions, distribute SLCF funds or enrol projects.
