Explanation

Trading accounts compare the amount of funding received from charging schemes with the actual resources allocated by SEPA.

Actual resources calculated from Activity Time Recording (ATR) - filled in by everyone in SEPA.

There are c800 ATR activities. Some are clearly chargeable such as site inspections and some such as flooding should be funded by GIA.


Some need to be allocated using rules.

Example of rules

Scottish Pollution Release Inventory (SPRI) covers pollutants released from a site.

Proportioned using the number of waste activities, emissions to air, discharges to water & RAS.

Resources used to support SPRI = £207k



SPRI Resources allocated to Air = 30% of £207k = £62k
