# 1 Introduction

This annex provides a summary of the consultation undertaken and engagement opportunities provided through the river basin planning process in the lead up to the publication of the Solway Tweed river basin district river basin management plan (RBMP).

This annex explains how stakeholders have contributed to the development of the river basin management plan. It describes:

- consultation opportunities;
- active involvement in the river basin planning process;
- public access to information.

When the Water Framework Directive was transposed into UK legislation, separate provision was made for the Solway Tweed river basin district because it straddles the English-Scottish border. Under the regulations<sup>1</sup> for the Solway Tweed, SEPA and the Environment Agency are required to work jointly to deliver river basin planning.

The requirement to set up river basin district advisory groups (area advisory groups), as per Part 1 Section 17 of The Water Environment and Water Services (Scotland) Act 2003 (WEWS) does not apply under the Solway Tweed regulations. However, both SEPA and the Environment Agency recognised the value of the area advisory group structure for delivering active involvement in the river basin planning process. Therefore, a network of a national advisory group and eight area advisory groups, including the Tweed and Solway area advisory groups, with forums, was established in 2006. Information on the activities of these groups is in Table 2.

The WEWS act also contains requirements to:

- **Publish a statement setting out the steps (including consultation measures) which will be taken in connection with the preparation of the plan**

A plan of action – basin planning in the Solway Tweed river basin district report was therefore produced in 2007 for consultation, as summarised in Section 2:

It consists of two area advisory groups drawing together representatives from responsible authorities, non governmental organisations, industry, business and other stakeholders with an interest in the water environment at a local level. In addition, a small working group (of area advisory group members) was set up to review the key documents arising from the river basin planning process including the draft plan. The support and advice of national advisory groups is also taken into consideration, from both the national advisory group in Scotland and the national liaison panel in England.</li> <li>2. Membership Advisory group members were identified initially using responsible authority designations and the Article 5 characterisation assessments for the Solway Tweed river basin district along with key deliverers. In Tweed, this membership was compared and discussed with Tweed Forum, an existing stakeholder umbrella organisation in order to make best use of stakeholder resources. A first meeting of each advisory group was then held and representatives were invited to identify additional members required. The advisory group membership is flexible and has been adjusted to accommodate changes in river basin planning requirements.</li> <li>3. Role The overall role of the area advisory groups is to contribute to the river basin management planning process in their area and the preparation of their area management plan. They are a primary source of help, support and advice in all aspects of this work and bring important knowledge to the process.</li> <li>4. 	<p><b>Fish and Fisheries Advisory Group</b>  SEPA formed the Fish and Fisheries Advisory Group in order to strengthen our capacity to address issues relating to impacts on fish and fisheries. This group includes representatives from the Association of Salmon Fisheries Boards, the Rivers and Fisheries Trusts of Scotland, Scottish Natural Heritage and freshwater fisheries scientists from Marine Scotland Science as well as other relevant interests and SEPA staff. Discussions on representation from the Environment Agency interests are currently underway. This group, which met for the first time in March 2009, advises SEPA on strategic issues relating to the development of policy, guidance and research in the area of the protection of fish and fisheries. The remit of this group includes the potential impact of any controlled activities on fish populations. The group will not consider individual applications or regulatory decisions, but it will advise on the implications of SEPA's regulatory approach.</p> <p>It is intended that this group will replace the Fisheries (Electricity) Committee. The Fish and Fisheries Advisory Group will have a wider remit than the committee and will also consider the potential impact of all controlled activities, not just those related to hydropower developments, as was the case with the committee. The Fish and Fisheries Advisory Group has to date commented on the draft SEPA guidance for hydro developers and a research proposal to look at the impact of run-off from river hydropower developments.</p> <p><b>Consultations</b></p> <p><b>Scottish river basin management strategy</b>  Consultation responses from stakeholders led to the subsequent publication of the Solway Tweed river basin planning framework and establishment of the Solway and Tweed area advisory groups.</p> <p><b>Solway Tweed river basin planning: a plan of action</b>  The advisory groups were involved in an early development and review of the plan of action consultation report and provided examples and case studies of participation techniques to support the document. From September to November 2007, 28 meetings were held between SEPA and National Advisory Group organisations to further refine proposed contributions from the workshops, to document proposals and to identify opportunities for partnership working to deliver proposals. Existing and planned measures were included in the programme of measures and considered during the objective setting process.</p> <p><b>Area advisory groups</b>  Meetings were held with various organisations represented on the area advisory groups from late 2006 to mid 2007 to identify what they were already doing to protect and improve the water environment, so that these could be included in the programme of measures and objective setting process.</p>

	<p>We have held one-to-one meetings and sub group meetings throughout the basin with the various organisations represented on the area advisory groups and other key stakeholders. The purpose has been to keep those stakeholders actively involved in the process. In particular, the meetings have focused on identifying those measures already taking place, to protect and improve the water environment so these could be included in the programme of measures and objective setting process. We have also discussed what new partnership measures we can develop for the basin management plan. These additional measures were recorded as part of the programme of measures.</p> <p>In Tweed, reference was paid to the Tweed Forum's Catchment Management Plan as many actions contribute directly to the programme of measures and existing working groups were used. In the north Solway existing catchment groups were approached for information.</p> <p><b>Development of the draft river basin management plan and area management plans</b>  A sub-group of members from both the Solway and Tweed area advisory groups was formed in early 2008 (the Solway Tweed Editorial Team) to shape and develop the draft river basin management plan from an early stage. The area advisory groups reviewed two versions of the plan.</p> <p>In addition the area advisory groups supported the development of the area management plans. Advisory group meetings provided the opportunity for detailed comments on the text and group discussion on the key messages identified for the plans. A version of the plan was circulated to the groups for general review and comment.</p> <p><b>Heavily modified water body workshops</b>  The methods used to designate, classify and determine objectives for heavily modified water bodies (HMWBs) and artificial water bodies (AWBs) requires knowledge of the specific characteristics of the water bodies, as well as of the needs of the uses reliant on the modified or artificial characteristics. Much of the necessary knowledge was provided by companies and organisations concerned with managing the modifications on HMWBs/AWBs. Water managers and other stakeholders were involved through a series of workshops in this process to ensure all relevant information was incorporated into the assessments.</p> <p>Information on heavily modified water bodies can be found in Chapter 4 Heavily modified and artificial waterbodies.</p>

	<p><b>Operator workshops</b>  A three-day workshop was held in March 2008 and was attended by SEPA, Scottish and Southern Energy, Scottish Water, British Waterways, Alcan and Scottish Power to discuss HWMBs and AWBs related to their operations. The workshop applied UKTAG methodology which defines the measures which would be required to achieve good ecological potential. Assessments were made as to which HMWBs/AWBs were currently at good ecological potential and objectives were set for when those not currently at that status would reach it. This event was attended by 15 operators.</p> <p>A further stakeholder workshop, attended by 21 operators and stakeholders, was held in Aviemore in April 2009 to provide area advisory group (AAG) members (and any fisheries trusts and boards not represented on AAGs) with an opportunity to comment on the outputs from the operators' workshop and to provide us with additional information on the ecological potential assessments. Following this workshop five stakeholders submitted further information as part of the consultation process.</p> <p>A similar stakeholder workshop was held in August 2009 in/for the Solway Tweed area. It was attended by eight operators and stakeholders.</p> <p>The outputs from the workshops were collated and any proposed changes to good ecological potential made as required for the final river basin management plan. The work also provides SEPA and operators with the basis of forward planning over the next three river basin planning cycles.</p> <p>EA workshop in Tweed – 2007. Details of HWMBs was also posted on their website for information.</p> <p><b>HMWBs in coastal and transitional waters</b>  There are a number of HMWBs, such as ports, where assessment of good ecological potential was made. SEPA Marine Science staff consulted with local authorities and ports authorities as required to agree these ecological potential assessments.</p> <p>Information on heavily modified water bodies can be found in Chapter 5 Heavily modified and artificial water bodies.</p>
