This privacy notice explains how we collect and use personal information to enable us to carry out our regulatory duties under the <u>Regulatory Reform (Scotland) Act 2014</u> and the <u>Water</u> <u>Environment (Controlled Activities)(Scotland) Regulations 2011</u>, which may include:

- granting and administering of authorisations and maintaining registers
- investigating environmental complaints
- undertaking formal enforcement action
- maintaining our own accounts and records

The legal basis for processing this information is that it is necessary to perform our statutory duties (**public task**).

# Registrations

During the process of applying for a registration we will ask you the following personal information for the person that we may contact about the application:

- Name
- Address including postcode
- Email address
- Telephone number

We will only retain your personal information for as long as it is required for the legal basis noted above. Thereafter, your data will be confidentially destroyed.

SEPA is required to make the information on the Register publicly available and the information you provide may be placed on SEPA's public register which may be in any format including electronically on our web pages. The placement of such information will be subject to redaction of personal information unless this information is required as part of our Public Task.

Payment of fees for the registration will be carried out via the GOV.UK Pay service. SEPA will not have access to, or store, any financial information relating to the payment. #### How we share personal information
