We have accepted your Enforcement Undertaking offer, received by SEPA on 22 May 2018, with effect from 28 September 2018. Together with this acceptance, these form the Enforcement Undertaking which you must comply with.

This means that our investigation is complete. No further action will be taken by us in relation to the offence(s) covered by the Enforcement Undertaking as long as you comply with the Enforcement Undertaking fully. Please note that we will publish the Enforcement Undertaking in accordance with our Policy for communicating penalties and undertakings.

Your offer includes a voluntary contribution of £3500 towards our costs. Details of how to pay this contribution are provided overleaf.

What happens next?

We will carry out compliance inspections and investigations to make sure that you comply with the Enforcement Undertaking in full and meet the timescales set out in it. We may request information from you to demonstrate compliance.

We will inform you in writing when satisfied that the Enforcement Undertaking has been fully complied with.
