SEPA has accepted your Enforcement Undertaking offer, dated 10 May 2019. Your offer dated 10 May 2019, together with this acceptance letter, form the Enforcement Undertaking you must comply with.

This means that SEPA's investigation into the offence identified in your offer and referred to above is complete. No further action will be taken by SEPA in relation to that offence as long as you comply with the Enforcement Undertaking fully. Please note that we will publish the Enforcement Undertaking in accordance with our Policy for communicating penalties and undertakings, which can be accessed on our website.

Your offer includes a voluntary contribution of £9,600 towards our costs. Details of how to pay this contribution are provided overleaf.

## What happens next?

We will carry out compliance inspections and investigations to make sure that you comply with the Enforcement Undertaking in full and meet the timescales set out in it. We may request information from you to demonstrate compliance.

We will inform you in writing when satisfied that the Enforcement Undertaking has been fully complied with

If we are not satisfied that the Enforcement Undertaking has been complied with, we may issue a certificate of non-compliance. You will be informed if this happens.

If you cannot fully comply with the Enforcement Undertaking, please contact us as soon as possible. You can apply to us to vary the Enforcement Undertaking in exceptional circumstances, but any variation should provide equivalent benefit to the environment or communities, equivalent financial commitment and address any additional costs incurred by us. You will be informed if we agree to vary the Enforcement Undertaking.
