You can apply to us to vary the Enforcement Undertaking in exceptional circumstances, but any variation should provide equivalent benefit to the environment or communities, equivalent financial commitment and address any additional costs incurred by us. You will be informed if we agree to vary the Enforcement Undertaking.


