What happened or failed to happen? How did it happen? When did it happen?

On Monday 16th August 2021 while stirring slurry in the lagoon on farm I accidentally hit the lower side of the lagoon with the slurry stirrer, this ripped the lining of the lagoon. I was unaware of the extent of the damage/ implications of this until Sepa officers contacted me the following day explaining there was reports of pollution in the water ways in the local area.

What, if any, environmental impact was caused by the offending behaviour (e.g. any impact on water, air, land, human health or amenity)?

The environmental impact was that slurry got into the water system leaving the farm into the wider environment resulting in the death of fish & invertebrates in the local water systems.

Section 6

What, if any, costs did you avoid, or financial benefit did you make from the offending behaviour?

There was no financial gain from this incident.

Conversely there has been significant costs incurred to;

- -Act promptly to limit damage employing a digger immediately to divert leaking slurry away from the water course to immediately stop pollution entering the water course, following advice from Sepa investigating officers on what actions they required both immediately & in the coming weeks to restore the lagoon & improve its function.
- -Empty the lagoon -involved hiring 2 tractor & tankers for the day as well as a specialist suction tanker on day 1 (which was not very successful), so contract hired a digger driver to dig down into the lagoon & scoop remaining slurry out into 3 hired tractor & trailers for a day
- -Make repairs to the lagoon lining including digger work to reinstate banking,
- -Improvements to the function of the slurry lagoon including installation of a visual inspection chamber with overflow discharge diverted into the field to reduce risk of pollution entering water ways if there were to be a future leak,
- -Installation of a concrete embankment on the south-west corner of the lagoon for mixing/ extraction of slurry & subsequently hiring a contractor to seal the side of the lagoon liner onto the concrete plinth & provide warranty for works.

Digger Hire with operator to do all excavation works over several days £7500

Tractor & trailer hire 3x12x£35 £1500,

Tanker & driver hire £2000,

KCP suction tanker £1700/day hire,

Lagoon Repairs £2200,

Load of concrete for embankment (labour done by myself & farm employee) £800 Pipe fittings for inspection chamber & separate discharge & sluice shut off £1900

=£18100

How are you going to ensure the offence does not continue or recur and what date/dates will you have achieved that/those action(s) by? Please specify what will be done and the date which it will be done by.

Going forward I will not use the unguarded mixer device again as no longer feel comfortable with this device. I will employ contractors with more sophisticated mixing equipment with more appropriate safety guards in place to avoid the lagoon lining becoming damaged again. These actions have been implemented with immediate effect following the incident occurring.

I have engaged with the manufacturer of the slurry stirrer (notify them of this incident & enquire about updating their design to minimise the risk of another incident happening to another farmer elsewhere in the country. They have been receptive to discussions & have said they have since designed & developed a retrofit safety attachment - a lower leg to stop the propeller from being lowered onto a surface.

I have installed a concrete embankment so mixing can take place at a location that if equipment were to fail this material is not perishable.

I have installed a visual inspection chamber which will be checked regularly (weekly) for leaks.

I have diverted the overflow from this inspection chamber so in the unlikely event of a future leak slurry will be diverted to discharge into the field away from water ways to avoid contamination of the water course.

I will utilise contractors more frequently in future in a little & often approach to spreading slurry so this is not applied as thick & will ensure generous no spread margins around water ways are left free of slurry to minimise risk of water contamination while spreading. Immediate effect.

I will try to use contractors that have flow rate monitors so they can monitor the level of slurry being applied. Ongoing

In January 2021 (with support of government grant funding) I did purchase a dribble bar, we also purchased some piping in 2021 but require a slurry pump, hire tractor & flow meter to be able to spread my own slurry, I hope to do this in the coming year so I can do this task myself.

I have engaged with Sepa & NFU to write a blog to be entered in the NFU Leader publication which is distributed to approximately 8000 farmers monthly. We have liaised with Stuart Martin (Scottish Dairy Hub & Policy Manager for the NFU) who has committed to assist us with getting this published. The purpose of this article is to raise awareness to other farmers of the potential hazards of farm waste & how this can impact on the environment if not managed correctly/in the event of an accident/incident & how prompt corrective action & early cooperation with authorities is key to managing this. If the offer of EU is accepted we would work with the NFU to get this blog into a Leader Publication within the next 4 months.

What are you going to do to restore the environment to the state it was in prior to the offence having occurred? OR If restoration is not possible or not a viable option, what alternate actions are you going to do to benefit or improve the environment? What date/dates will you have achieved that/those actions by?

The incident caused fish to die, we have engaged with the Allan Water Angling Association to discuss contributing towards restocking the river. However they advised that re-stocking is not something they currently do as scientific evidence does not support this. They work closely with the Forth Rivers Trust on any projects involving the river. They have shared with me a copy of their 5 year management plan which sets out the activities the association is looking to embark on in the next few years. The association have 3 focus areas being River Improvements, Angling Improvements & Administrative improvements. We have discussed what we could collaborate on that would help them to improve the environment around the river. If this EU is accepted we would make payment to the angling association within a 3 month period.

We commit to make a donation of £1250 to Allan Water Angling Association as a contribution towards their priorities primarily this will be used for improving private access through the purchase of materials to repair styles & instal kissing gates, provide labour to improve pathways. This payment can be evidenced by copy of cheque/BACs leaving our account/receipt from the Association.

We commit to make a donation of £1250 to Forth Rivers Trust to sponsor one primary school (preferably Dunblane or if they decline to participate another as matched by the Forth Rivers Trust) to participate in the 'Fish in the Classroom' educational activities. This would be paid when required by the Rivers Trust (November onwards). Similarly this payment can be evidenced by copy of cheque/BACs & receipt from the Rivers Trust

What additional commitments are you making to benefit or improve the environment? What date/dates will those commitments be fulfilled by?

We have also engaged with the Forth Rivers Trust to discuss what projects we could support them & to help benefit the environment/local population's enjoyment of the area. After meetings & discussions we have committed to sponsor an education programme called Fish in the Classroom for the primary five children in Dunblane Primary School. The project runs yearly from January to March when the Trust engages with schools across the Forth to provide an interactive learning experience to children. This educates the children on the life cycle of the Brown Trout & gets them to nurture Brown trout from eggs, fry into baby fish & log their progress until ready to be released into the river. Staff from the trust then accompany the children on an educational visit to the river to release the fish in the river & learn about other invertebrates & the environment whist on their trip. Fish in the Classroom | Forth Rivers Trust This project is undertaken annually in the spring to coincide with the Trout spawning & hatching season. Schools are approached in November. In the event Dunblane

primary school do not wish to participate in 2023 we will sponsor another school as identified by the Rivers Trust. This will be paid when required by the Trust ahead of the project beginning (within 6 months).

The local community have not directly been affected by this incident. Recreational hobbies of those within the community may have been indirectly impacted through fish kills. I have not consulted with the community directly on this but through our engagement with the Angling Association & Forth Rivers Trust hope we can make some positive contribution to the local community through improving public access & school educational programme.
