THE ENVIRONMENTAL REGULATION (ENFORCEMENT MEASURES) (SCOTLAND) ORDER 2015 ("the Order")

FIXED MONETARY PENALTY NOTICE

To: Bellway Homes Limited

Newcastle Upon Tyne

The Scottish Environment Protection Agency ("SEPA"), hereby notifies you, that you are liable to a Fixed Monetary Penalty (FMP) because SEPA is satisfied on the balance of probabilities that you have committed a relevant offence prescribed under the Order, namely an offence under Regulation 44(1)(d) of the Water Environment (Controlled Activities) (Scotland) Regulations 2011 ("CAR 2011"), in that you did fail to comply with or contravene a water use licence (including any conditions imposed), namely condition 3.2.1(b) specified in water use licence CAR/S/5002708 in relation to the level of suspended solids in discharges of treated surface water from Phase 2, Johnston Road, Gartcosh (also known as Cloverhill) construction site, as more particularly described below.

Grounds for imposing the penalty: In terms of Regulation 8 and subject to Part 2 of Schedule 10 of CAR 2011, a controlled activity may be authorised by a water use licence if it is carried out in accordance with the conditions provided for in this regulation.

A 'controlled activity' is an activity referred to in Regulation 3 of CAR 2011. Regulation 3 specifies a number of activities, which includes 'activities liable to cause pollution of the water environment'.

Paragraph 2 of Regulation 8 of CAR 2011 requires that SEPA must impose such conditions in a water use licence as it considers necessary or expedient for the purposes of-

- (a) Protection of the water environment.
- (b) Enhancement of the water environment; or
- (c) Protection of the interests of other users of the water environment,

and such conditions may include monitoring requirements.

It is an offence under Regulation 44(1)(d) of CAR 2011 for a person to fail to comply with or contravene a water use licence (including any conditions imposed).

On 02 November 2022 SEPA received reports that silty brown discoloured water was running off the Cloverhill construction site in Gartcosh and down the adjacent field towards Johnston Loch. At 15.35 hrs on 02 November 2022, authorised SEPA officers observed significant amounts of silty brown water flowing from the stripped area of the Phase 2, Johnston Road, Gartcosh (also known as Cloverhill) construction site, through the Heras fencing/newt fence boundary, down the hill in the adjacent field and collecting at a low point located at NGR NS 69833 68770, adjacent to Lochend Road and opposite Johnston Loch.



The brown silty water running off the construction site was bypassing any treatment infrastructure in place. A sample of the silty water collecting at location NS 69833 68770 taken by the SEPA officers on 2 November 2022 contained a level of 1340 mg/l suspended solids.

SEPA issued a water use licence (CAR/S/5002708) to Bellway Homes Limited on 12 July 2022 which contains conditions relating to the discharge of water run-off from construction works at Phase 2 Johnston Road, Gartcosh construction site to the water environment. Condition 3.2.1(b) specified in water use licence CAR/S/5002708 states that the discharge of water run-off from the construction site must not exceed 80 mg/l suspended solids. The location of the sample of silty water run-off collected by SEPA officers at NGR NS 69833 68770 on 02 November 2022 was outwith the site boundary as indicated in Appendix 1 of water use licence CAR/S/5002708. As this sample contained 1340 mg/l suspended solids, it constitutes a breach of condition 3.2.1(b) of said water use licence.

During a follow-up visit to the Phase 2, Johnston Road Gartcosh construction site on 14 November 2022, authorised SEPA officers noted that brown discoloured silty water was being conveyed from lagoons on the construction site via a pipe to a small ditch located at NGR NS 69960 69002 in the adjacent golf course. SEPA officers collected a sample of the silty water entering said ditch from the construction site on 14 November 2022 and this sample contained 3880 mg/l suspended solids. The location of the sample of silty water run-off collected by SEPA officers at NGR NS 69960 69002 on 14 November 2022 was outwith the site boundary as indicated in Appendix 1 of water use licence CAR/S/5002708. As this sample contained 3880 mg/l suspended solids, it constitutes a breach of condition 3.2.1(b) of said water use licence.

SEPA is satisfied that Bellway Homes Limited failed to comply with condition 3.2.1(b) specified in water use licence CAR/S/5002708 on 02 November 2022 and 14 November 2022, namely the discharge of water run-off from the construction site must not exceed 80 mg/l suspended solids and as such you did commit an offence in terms of Regulation 44(1)(d) of CAR 2011.

Date of offences: 02 November 2022 and 14 November 2022

Location of offence: Phase 2, Johnston Road, Gartcosh construction site

The amount of the FMP is £600.

You are required to pay the sum in full within 56 days beginning with the day this notice is served on you.

Amount of Penalty and effect of payment

The penalty has been set in accordance with the Environmental Regulation (Enforcement Measures) (Scotland) Order 2015 ("the Order").

How to Pay a Fixed Monetary Penalty

Late payment and Non-payment

If you do not pay the full amount owed within 56 days beginning with the day this notice is served on you, the amount due will be increased by 40% in accordance with the Order. SEPA can recover sums due but not paid in full as a civil debt.

Appeals

You can appeal against this Notice to the Scottish Land Court within 28 days beginning with the date of service of this Notice on the grounds that:

- The decision was based on an error of fact
- The decision was wrong in Law
- The decision was unreasonable
- any other reason, (with the exception that the Order states that it is not a valid ground of appeal that SEPA failed to comply with the Guidance issued to it by the Lord Advocate under the Act).

You should submit your Appeal to The Scottish Land Court, George House, 126 George Street, Edinburgh, EH2 4HH. An application form for an appeal can be obtained by contacting the Court on 0131 271 4360 or from the Court's website at http://www.scottish-land-court.org.uk/using/making-an-application. It would be helpful if you also sent a copy of your appeal documentation to SEPA, The Registry Department, Angus Smith Building, 6 Parklands Avenue, Eurocentral, Holytown, Motherwell, ML1 4WQ.

The bringing of an appeal will have the effect of suspending payment of the penalty until after the appeal has been determined or withdrawn.
