We will carry out compliance inspections and investigations to make sure that you comply with the Enforcement Undertaking in full and meet the timescales set out in it. We may request information from you to demonstrate compliance.

We will inform you in writing when satisfied that the Enforcement Undertaking has been fully complied with.

If we are not satisfied that the Enforcement Undertaking has been complied with, we may issue a certificate of non-compliance. You will be informed if this happens.

If you cannot fully comply with the Enforcement Undertaking, please contact us as soon as possible. You can apply to us to vary the Enforcement Undertaking in exceptional circumstances, but any variation should provide equivalent benefit to the environment or communities, equivalent financial commitment and address any additional costs incurred by us. You will be informed if we agree to vary the Enforcement Undertaking.
